

Terms & Conditions :-

1. Parent is responsible for his ward regarding this exam and traveling there ward to the examination center & again back.
2. After verifying the identity of the official coordinator of Manthan Welfare Foundation, deposit the examination fee to him and get the acknowledgment receipt attached with the application.
3. Exam center will be at Tehsil (Taluka) place or at a convenient place in that Tehsil (Taluka).
4. In case, if any event will be organized, suddenly at exam center on the same day of an exam, another exam center will be managed instantly as a standby provision not disturbing candidates appearing for exam. In managing so, there may be late/delay to start an exam by half an or a hour. In such there may be late/delay to start an exam by half an or a hour. In such situation, it is our kind request to you all parents/guardians with their wards to keep patience and co-operate with co-ordinators and their exam organisation team.
5. Due to some unavoidable reasons/circumstances, if exam center will not be available then there is right to exam organisation committee to change and postpone exam date of the students at concerned exam center.
6. Result of exam will be available on authorised website of **Manthan Welfare Foundation**, www.manthanwelfarefoundation.org. The final answers list (key answers) of final exam and the solved OMR answer sheet by a candidate will be available on website and he/she can take its printout as well.
7. In case, if benches will not be available at exam center. The candidates may have to sit on the ground to give written exam. So, it is advised hereby to all the students to bring with them writing pads and necessary exam related materials.
8. In case, due to some unavoidable circumstances, if center school will not be able conducting exam, then sitting arrangement of students and conducting their exam, will be managed by arranging another multipurpose hall, auditorium or open spaced ground. The students have to give exam by sitting on ground.
9. No other stand-by provision will be made by exam organisers for those students who have admitted for other exams held on the same day, by other organisations.
10. According to the information filled in the admission application form, some guidelines or necessary information are given to the students/ parents through SMS from time to time (Whats App or text message). Also, It will be the responsibility of the concerned student and parent to check all the information printed on the admit card given before the exam.
11. It will also be the responsibility of the concerned student to check whether the question paper and answer sheet distributed to the student is according to his/her class (standard) and medium. But the age group of the students is small (young), if there is any mistake by the examination system during the examination and if it is noticed in time, the appropriate action will be taken at the examination center itself and if it is not noticed, then the decision taken by the examination department in the interest (favor) of the students will be accepted by me. I will not complain about it.
12. All the rights of declaration of prizes are reserved with exam organisers only. Also, only exam organisers will decide to rise or deduct the number of prizes to be given, depending upon total number of candidates appeared for exam.
13. If there will be problems/difficulties in conducting written exam in current academic year (2026-27), due to emergency situation, exam will be conducted by online videos and in controlled pattern by artificial intelligence Proctor. Rules and Regulations regarding online exam will be conveyed to the students. Online exam will be voluntary. Some partial changes in exam syllabus and exam schedule may occur. If candidate is not interested to give online exam, the exam conducting institution is bound to refund application form fee Rs. 50/- (he/she had paid for exam) to him/her.
14. One ranked candidate will receive only one prize, either state level, district level or center level.
15. District / with regard to divisional level prizes, a valid and fair competition will be created according to the number of examinees in the respective district and a proper merit list will be prepared and to do so, some districts will be combined to form a division. While preparing the merit list of such students, the divisional merit list will be prepared instead of the district merit list.
16. **'Manthan Welfare Foundation'** is an autonomous, registered institution led to social responsibilities, commitments and welfare and so, they have rights to plan or change the exam schedule as decided by institutional exam committee.
I have read authority letter given to **'Manthan Welfare Foundation'** issued by Dept. of School Education, Government of Maharashtra for conducting exams at school levels and understood thoroughly. As a parent/guardian, I am paying exam fee ₹ 50/- only voluntarily & I got the acknowledgment of form submission.
17. The amount spent by me for buying extra material of exam (Guides, paper sets for practice, private coaching classes, online classes & online Tests etc.) is not related in anyway to the fee of exam being conducted by **'Manthan Welfare Foundation'**. I am aware of things and buying this educational material on my own, for enhancement in educational quality of my ward.
18. The difficulty level of this exam is supplementary to school curriculum and hence, there will be no adverse effect on candidate due to extra stress of study. Instead, I know it will lead to the growth/enhancement in educational quality and study of candidate. The Manthan Welfare Foundation does not determine the quality or study ability of the examinee in any way. It does not make any negative comments while determining the intellectual level of the students. Therefore the Foundation denies the responsibility for any mental pressure that may come on the examinee in connection with the examination. Parents / Guardians should always be aware of this.
19. As a parent/guardian, it will be my responsibility for omission/exclusion of my ward from exam at any stage throughout the exam process, for providing wrong information in application form either online or offline. I know, under this situation, no exam fees of my ward will be refunded to me.

21. All legal aspects regarding exam come under the jurisdiction of Hon. District court, Ahilyanagar.

State Level & District / Divisional Level Prize :

If the prize-eligible (winning) students of each class have equal marks, the State Level and District/Divisional Level prize money amount will be divided accordingly. The State Level prize money amount distributed will be a minimum of ₹ 400/- per student. The District/Divisional Level prize money amount will be a minimum of ₹ 300/- per student. With the aim of having energetic and vigorous, healthy competition according to the number of participating students of the respective district, a divisional level will be created for prizes by combining some districts. The prize money amount will be credited directly (EFT) only to the student's/parent's bank account. All the prize-winning students will be honored with a memento.

Center Level Prizes :

Center Level Prizes based on 300 students in each class maximum upto the 7th rank or if the number of students in a class is less than 300, then 5% of the number of students according to the class will be awarded in order of merit ranking. The prize money amount will be credited directly (EFT) only to the student's / parent's bank account. The prize money amount ₹ 150/- and memento shall be given to the prize winner students.
